INTRODUCTION


- "Discretion is defined as power of free decision or latitude of choice within certain legal bounds."

Low Disorder	 Gambling If done publicly and organized , is illegal Not very harmful or chaotic 	 Possession of Cannabis for personal use Over a certain amount police must charge offender With no plans to distribute there is a low level of chaos/disorder
