## The Underreporting of Sexual Assault Cases

Sexual Assault is severely underreported according to the US Bureau of Justice Statistics (2010.) With television shows such as *Law & Order: SVU*, there is a misinterpretation of the processes of sexual assault cases in the Criminal Justice System. Even though this crime is underreported, it is more common than you think. In college alone, 1/5 women will be assaulted, and only 20% will report the assault. So, the main question is "Why?" To answer this, we have to gain empathy for the victim, and to understand the context of their life, daily routines, and socialization.

## The Processes

- Investigations
  - Place of assault
  - Forensic exam (rape cases)
    - Swabbing oral cavity, rectum, reproduction areas, etc
- Sentencings
  - Light Sentencing
  - Time not fully served (released early)
  - · NO JUSTICE

## **Examples of Cases**

- Michael Hill (24)
  - Had sexual relations with a minor
  - Sentenced 12 years to prison
    - Only served 4 days due to clean criminal record
    - Case was
- Judge John F. Russo Jr.
  - Victim blamed in court in 2016 during court
  - Was removed from the bench and owed a fee of \$250,000
